- · Overall Bond Program is progressing well
- We started Sterling HS CTE lab design phase as well as the Phase 1C for Education Service Center Building.
- San Jacinto project has made up ground. Now that we have a contract, the Contractor has mobilized and we are able to catch up. We are on schedule
- ES #17 the contractor is moving at a fast pace and we should be ahead of schedule
- Phase 4 we are catching up and making up ground on the overall schedule
- Lee HS Auditorium we are behind but that is because of a recent discussion with the City of Baytown in regards to the sprinkler system. The 1st meeting with City of Baytown it was determined we wouldn't have to sprinkler the building however the City is now requesting for the fire sprinkler system to be included in the project.

- Answer: December of 2021 due to land negations it has been pushed back a semester.
- Question: Will rezoning be necessary?
- Answer: The District will decide but I (Brenda) don't think it will be necessary because you are just moving students.
- Question: Why isn't the project budget staying consistent? ESC and Roof Replacement doesn't show the same 4% as the other budgets.
- · Answer: Part of the roof replacement went to MEP #1 roof replacement project (Sterling HS) and ESC roof replacement.
