JUNIOR SCHOOL BOUNDARIES OPTION 2

BAYTOWN JUNIOR SCHOOL

Beginning at the corner of Interstate 10 and Spring Bayou, the boundary goes east on Interstate 10 to Wade Rd. (includes south side of Interstate 10), south on Wade Rd. to W. Cedar Bayou Lynchburg Rd. (includes west side of Wade Rd.), east on W. CB Lynchburg Rd. to Goose Creek Stream (includes both sides of W. CB Lynchburg Rd.), south along Goose Creek Stream to Village Ln. extended. South on Village Ln. to W. Baker Rd. (includes Village Lane but does not include 4601 Village Ln.), west on W. Baker Rd. to Decker Dr./Spur 330 (includes north side of W. Baker Rd.). South on Decker Dr./Spur 330 to Fairway Dr. (includes west side of Decker Dr.). North on Fairway Dr. to Glenhaven Dr., east on Glenhaven Dr. until it dead ends into Goose Creek Stream (does not include Fairway Dr. or Glenhaven Dr.). South along Goose Creek Stream to Rollingbrook Dr., east on Rollingbrook Dr. to Hutto Blvd. (includes south side of Rollingbrook Dr.), south on an imaginary vertical line from Hutto Blvd. extended to Decker Dr. South on Decker Dr. to Market St. (includes west side of Decker Dr.), west on Market St. to Carnegie St. (includes north side of Market St.). South on Carnegie St. to an imaginary vertical line that runs south to Thompson St. (includes both sides of Carnegie St.). Continuing south on Thompson St. to W. Main St. (includes both sides of Thompson St.), east on W. Main St. to Lee Dr. (includes south side of W. Main St.). South on Lee Dr. to Tabbs Bay (includes west side of Lee Dr.), north along the bay coastline to Spring Bayou, north along Spring Bayou to Interstate 10.

CEDAR BAYOU JUNIOR SCHOOL

Beginning at the corner of N. Highway 146 and N. Main St. the boundary goes south to Ward Rd. (includes east side of N. Main St.). East on Ward Rd. to N. Alexander Dr. (includes north side of Ward Rd.), south on N. Alexander Dr. to E. James St. (includes east side of N. Alexander Dr.), east on E. James St. to Cedar Bayou Stream (includes north side of E. James St.). North along Cedar Bayou Stream to Cove Rd. East on Cove Rd. to district line (includes both sides of Cove Rd.), west on Cove Rd. to FM 1405. North on FM 1405 to an imaginary horizontal line between Kaitlyn Ln. and Twisted Oak St. Continuing west on that line to Cedar Bayou Stream. North along Cedar Bayou Stream to an imaginary horizontal line extended from Roberts Blvd. West on Roberts Blvd. to Dozent Ln. (includes both sides of Roberts Blvd.), north on Dozent Ln. (includes both sides of Dozent Ln.). West on an imaginary line north to Dozent Ln. to Cedar Hollow St., west on Cedar Hollow St. to Timber Ridge (includes both sides of Cedar Hollow St.), south on Timber Ridge to E. CB Lynchburg Rd. (includes both sides of Timber Ridge). West on E. CB Lynchburg Rd. to Barkaloo Rd. (includes both sides of E. CB Lynchburg Rd.). South on Barkaloo Rd. to E. Baker Rd. (includes east side of Barkaloo Rd.). West on an imaginary horizontal line to N. Main St., south on N. Main to N. Highway 146 (includes east side of N. Main St.).

GENTRY JUNIOR SCHOOL

Beginning at the corner of Garth Rd. and Interstate 10, the boundary goes east on Interstate 10 to Needlepoint Rd. (includes south side of I-10), east on Needlepoint Rd. to the district line (does not include Needlepoint Rd.). South on district line to Cove Rd. West on Cove Rd. to FM 1405 (does not include Cove Rd.). North on FM 1405 to an imaginary horizontal line between Kaitlyn Ln. and Twisted Oak St. Continuing west on that line to Cedar Bayou Stream. North along Cedar Bayou Stream to an imaginary horizontal line extended from Roberts Blvd. West on Roberts Blvd. to Dozent Ln. (does not include Roberts Blvd.) north on Dozent Ln. (does not include Dozent Ln.). West on an imaginary line north of Dozent Ln. to Cedar Hollow St., west on Cedar Hollow St. to Timber Ridge (does not include Cedar Hollow St.). South on Timber Ridge to E. CB Lynchburg Rd. (does not include Timber Ridge). West on E. CB Lynchburg Rd. to Barkaloo Rd. (does not include E. CB Lynchburg Rd.). South on Barkaloo Rd. to E. Baker Rd. (includes west side of Barkaloo Rd.). West on an imaginary horizontal line to N. Main St. South on N. Main St. to N. Highway 146 (includes west side of N. Main St.), west on N. Highway 146 to Decker Dr./Spur 330 (includes north side of N. Highway 146). North on an imaginary vertical line to Rollingbrook Dr. and Hutto Blvd extended. West on Rollingbrook Dr. to Goose Creek Stream (includes north side of Rollingbrook Dr.). North along Goose Creek Stream to an imaginary vertical line extended to Glenhaven Dr., west on Glenhaven Dr. to Fairway Dr. (includes Glenhaven Dr. and Fairway Dr.). South on Fairway Dr. to Decker Dr./Spur 330, west on Decker Dr./Spur 330 to W. Baker Rd. (includes east side of Decker Dr.), east on W. Baker Rd. to Village Ln. (includes south side of W. Baker Rd.). North on Village Ln. to Goose Creek Stream (does not include Village Ln. but does include 4601 Village Ln.), north along Goose Creek Stream to W. CB Lynchburg Rd., east on W. CB Lynchburg Rd. to Garth Rd. (includes both sides of W. CB Lynchburg Rd.), north on Garth Rd. to Interstate 10 (includes east side of Garth Rd.).

HIGHLANDS JUNIOR SCHOOL

Beginning at the corner of Spring Bayou and Interstate 10, the boundary follows the bayou north to Jones Rd., west on Jones Rd. to FM 2100 (includes both sides of Jones Rd.), continues west on a horizontal line extended to the San Jacinto River, follows the shoreline north to a horizontal line extended west to the river from Barbers Hill Rd., east on that horizontal line and continues east on Barbers Hill Rd. to FM 1942 (includes area south of Barbers Hill Rd.), continues east on FM 1942 to Cedar Bayou (includes area south of FM 1942), south along the bayou to Interstate 10, west on Interstate 10 to Garth Rd. (includes north side of I-10). South on Garth Rd. to W. CB Lynchburg Rd. (includes west side of Garth Rd.), west on W. CB Lynchburg Rd. to Wade Rd. (does not include W. CB Lynchburg Rd.). North on Wade Rd. to Interstate 10 (includes east side of Wade Rd.), west on Interstate 10 to Spring Bayou (includes north side of I-10).

HORACE MANN JUNIOR SCHOOL

Beginning at the corner of Decker Dr. and N. Highway 146 the boundary goes east on N. Highway 146 to N. Main St. (includes south side of N. Highway 146). South on N. Main St. to Ward Rd. (includes west side of N. Main St.), east on Ward Rd. to N. Alexander Dr. (includes south side of Ward Rd.). South on N. Alexander Dr. to E. James St. (includes west side of N. Alexander Dr.), east on E. James St. to Cedar Bayou Stream (includes south side of E. James St.). North along Cedar Bayou Stream to Cove Rd., east on Cove Rd. to district line (does not include Cove Rd.). South along district line to Trinity Bay, south on bay coastline to Lee Dr. extended. North on Lee Dr. to W. Main St. (includes east side of Lee Dr.), west on W. Main St. to Thompson St. (includes north side of W. Main St.), north on Thompson St. to Carnegie St. extended (does not include Thompson St.). Continuing on Carnegie St. to Market St. (does not include Carnegie St.), east on Market St. to Decker Dr. (includes south side of Market St.), north on Decker Dr. to N. Highway 146 (includes east side of Decker Dr.).
