All graduating seniors attending a community college, four-year college or university, or technical school for the Fall 2010 **MUST** complete the Free Application For Federal Student Aid (FAFSA). The purpose of the application is to determine financial need or eligibility for financial assistance. Financial assistance can be in the form of grants (free money), or loans (borrowed money typically with interest). This application should be completed online at [www.fafsa.ed.gov](http://www.fafsa.ed.gov). GCCISD, in partnership with Lee College, will be offering **FREE** Financial Aid Workshops to assist students and parents complete the FAFSA. Dates and times are listed below.

##### Parent/Guardian Information

- 2009 tax return
- 2009 W-2 form
- social security number(s)
- marital status

##### Student Information

- 2009 tax return
- 2009 W-2 form
- social security number

Parents and students who **will not** file taxes can still attend the workshops and complete a FAFSA .
