SENTINEL/TEA

REFERRAL PROCESS

Rachel Brady spoke about the SPED referral process and shared a presentation on GCCISD Special Programs and Special Education & Section 504. Since 2024-15, there has been a 72% increase. For 2023-24, there were 1052 students referred for an FIIE. 912 evaluations has been completed. Most common referrals are SLD and Speech. Speech evals take 4-6 hours and SLD's take 11-15 hours. Students should be serviced under Rtl w/fidelity and documented in eSped. Copies of the questions will be sent out to committee members.

TEA LAWSUIT

James Husband explained the TEA Lawsuit. Ratings have not been released. September 16th will be the next hearing.

- How is the student accessing and progressing in the gen ed curriculum?
- Does the student have access to high quality instruction from a certified teacher?
- Is the student at a level consistent with grade expectations?
- How does the student compare to others in class and grade level?
- What is the student's current and expected performance?
- Screening data? How does the student compare to class? Grade level?
- What interventions are in place?
- What Tier 2 or Tier 3 interventions are in place in addition to interventions provided to the whole class?
- How is the student progressing in the interventions?
- Does the student have excessive absences?
- Does the student have a history of disciplinary referrals?
- Is English the student's first language?
