Question/Answer

Question: On Education Service Center Phase 2 project, how much value engineering are you going to have to do?

Answer: It would be substantial in order to stay within our budget. We have to revisit and figure out what those functions are for that building and how we will meet those functions that we said we'd meet. We have not had that conversation internally or with the administration at this time. They have been informed about the bid cost but we have not schedule a follow-up meeting.

Question: After about 2 years from now, if we need to make any internal changes will we have to find internal money to make

those changes?

Answer: It is a possibility, yes.

Question: Have we not already reduced the capacity size?

Answer: We have it at five hundred.

Question: We are still too high on cost?

Answer: Yes, we knew that the cost was going to be high but, just not this high. The cost continues to climb and we are over 600 dollars a square foot.
