Question/Answer:

Question: On the computer replacement is that for all campuses?

Answer: Yes, we still have 150 computer replacements to do for all campuses.

Question: Can you break down the numbers you are requesting for the endorsement?

Answer: My numbers for the 1.8; I have about a million dollars for 2,000 staff member iPads for replacement, the VPN is going to be \$70k, for the inventory usage-\$230,000 for a 5-year period of usage, for Cisco upgrades \$200,000, for purchasing a replacement future fire wall \$300,000, and also calculating in the E-Rate for cybersecurity replacement.

Question: Is the 1.8 coming out of the budget not a additional amount?

Answer: Correct.

Question: Is the thought that this money stays in technology or can it go to other projects as needed?

Answer: It would depend on the feedback we receive from all of you. We will not take funds from the technology department or any project unless the project is completely done.

Question: Do the teachers and principals use their iPads?

Answer: Yes, it is used by both; all staff.

Question: Are the teachers using their laptops instead of their iPads?

Answer: My hope is that they are not. They should be using their iPads because that is what we have pushed through training.

Question: Would you prefer to buy iPads for students instead? (The issue is, we do not have enough iPads to maintain for everyone's use.)

Answer: Buying new iPads for teachers and staff would allow their iPads to be issued to students

Question: Do they have iPads in every classroom?

Answer: I have 5 iPads in every classroom.

Question: Can they pull iPads from other classrooms for testing?

Answer: Testing is a timely matter and would make it very difficult for teachers and staff to not have an iPad for each student.

Question: If you didn't have the money you do now; come November and you couldn't fix broken-down iPads what would you do?

Answer: I would have to go in front of the Board and request an endorsement, but note the bond money would cover the cost.

Question: How hard is this on you?

Answer: It's a logistics thing, this is not anyone's fault. It's Apple changing their standards.

Question: I know there is a motion out there, but to respect your endorsement, is it best that this item gets pulled?

Answer: We can come back to this later and discuss.

Question: What other projects looking down the road might we need funding for?

Answer: On San Jacinto and Fine Arts Building, will need to come back and request an endorsement. On the Field House and Education Phase 2 projects, we are cutting it close, but at this time we are balancing out our budgets and reviewing all project funds.

Question: Was there any damages to the Field House during Beryl?

Answer: No, other than delays due to the weather.

Question: Where are we on Education Service Center Phase 2?

Answer: We might have some change orders coming, but it is within our budget expense right now.

Question: Are there going to be projects completed by September and/or October?

Answer: October is the date we have for the Field House and Education Service Center Phase 2 is in the spring.

Question: What happens if we get a Category 3 Hurricane and we have damage, were does all that money come from?

Answer: It would be on the contractor; they are bonded to complete those projects. That expense will not fall on us.

Question: Are we saying we are in agreeance that we are not going to vote for the endorsement the way it is?

Answer: The way you resolve this is to address the motion is on the floor.

Question: Has anyone seconded the motion?

Answer: No, not at this time.

Question: Do we call a vote since there are 5 of us?

Answer: The motion has been made; so we either proceed or we don't, then go with the next

recommendation.

Mr. Beard motioned to endorse the request, but exclude the replacement of the staff iPads.

No one seconded the motion.

Brian Miller motioned to endorse the 1.8 million as-is to replace Staff iPads and implement backend security solutions for improved management and insight for all iPads.

Tim Christensen seconded the motion.
