Question/Answers

Question: What happens in a classroom when a student does not get assigned an iPad?

Matt Flood responded: (See Replace Elementary and Junior School Mobile Devices & Add Elementary and Junior School Mobile Devices) In a classroom setting we will have a table/cart with 10 slots to hold 5 iPads and 5 battery packs for students to use. Students will be allowed to check out a device or charge their current device when bringing it from home.

Question: After requesting the endorsement for \$4,676,000 will we have 8 million left from the current bond balance of \$12,672,602.20?

Matt Flood responded: That would be correct.

Question: So we will achieve one to one iPads, a classroom set and still have 8 million left?

Matt Flood responded: Correct.

Question: On the 2nd endorsement to replace High School iPads and upgrade keyboard cases; do we have the FCC funding vet?

Matt Flood responded: No, not yet. Per the FCC, they have committed if I can match the numbers then they will reimburse me.

Question: Out of the 8 million left the 4 million will be spent on 2nd Endorsement which will leave us with at least 4 million, but if the FCC reimburses us we will have up to 6 million left on that bond?

Matt Flood responded: Correct.

Question: Is there an issue with ordering IT equipment because of everything being on back order?

Matt Flood responded: Right now, Apple is telling me 7 to 9 weeks lead time on iPads but depending on time of purchase the expected arrival can be pushed back further. There is definitely and issue with technology getting parts, chips, supplies and components.

Question: So you don't have a contract out right now because the endorsement has not been approved?

Matt Flood responded: I don't.

Question: Do you feel good about the pricing?

Matt Flood responded: How Apple works with the State of Texas is that they already have pricing with Texas DIR (Texas

Department of Information Resources). Schools can only purchase iPads from Apple using the Texas DIR pricing, no negotiation.

Question: Are we anticipating any problem opening new school because of equipment and schedule delays?

Dr. McCall responded: Yes, and we are going to talk about it.

Answer/Questions

Question: Is the commute time affecting our kids getting out of school and getting home?

Rick Walterscheid responded: It is a challenge. We have seen 2 things this year: reduction in ridership because of Covid and increase of traffic at our campuses and the community to and from school. Nonetheless, we still have to intermingle with that when transporting fewer kids. That tells me, in one way by combining routes and meeting the shortages, but it also adds to the compound of the problem at campuses. There is no easy one fix to this. We're going to have to dump more kids out to get them on time.

Dr. O'Brien commented: He would like to close the departure by 30 minutes, meaning that every Jr High student and teacher is getting home 30 minutes earlier than they did last year. So when we are running late it is still not as late as last year.

Rick Walterscheid commented: Some variables that may cause an issue would be preschoolers being dropped off (no preschoolers will be dropped off without a parent present) and I just cannot control the trains.

Question: You mention something about an endorsement on the 15 new buses, what is the purpose for that endorsement? **Rick Walterscheid responded:** I apologize, I misspoke this will be a notification not an endorsement. We currently have \$3.5 million in that account. I would like to look at what are our needs for next year; 15 buses and the following year we would close out with an additional 18 to 20 buses.

Question: What are we paying for this?

Rick Walterscheid responded: Somewhere between \$105,000 to \$109,000 depending on Special Ed vs. Regular Ed.

Question: That will get us all the buses we plan for?

Rick Walterscheid responded: That is going to get us more than the buses we planned for. We got really good deals.

Question: We are not going to approve something, you're just going to tell us the good news.

Rick Walterscheid responded: Yes.

Question: Back on the supply chain issue, are there any other issues besides computer, buses, lumber, and furniture issues? **Dr. McCall responded:** Furniture, appliances and FF&E is a huge concern on the opening dates we set for some of the campuses and the lead time we are getting from our suppliers are 2 and 3 times the length of our expectations.

Question: Have we ordered all the furniture for those two schools?

Clem Medina responded: San Jacinto furniture has been ordered, but on Phase 4 we ordered way in advance. When we call and contact the vendor, they respond by telling us another 8 weeks for our delivery.

Question/Answers

Question: Are we not using our standard elementary site designs?

Dr. O'Brien responded: Its the same exact footprint, the endorsement previously was to just re-organize the instruction under the roof. One wing will have Pre-K and outside of that is just a re-configuration of the students.

Question: Are we going to have lights out there on the tracks?

Bruce Riggs responded: No light at this time.

Question: On the Stallworth Field House we begun the assessment of the site facilities, is that part of the bond scope with the repairs to the existing facility or just opportune time to do an assessment?

Dr. McCall responded: As far as the Field House is concern that is part of the bond, but the assessment of the actual site is something that the district is doing outside the bond.

Dr. O'Brien: commented: On our next bond in 2023 we could repair and upgrade the current Stallworth Field House or we could build a brand new stadium, but that will be left open to you and our community to decide at a later date.

Question: Do we move forward to substantial renovation to the stadium itself or do we want to build something new somewhere else? It's a good time to do that assessment.

Clem Medina responded: That is exactly were we are at, we want to understand that facility a little more. Once we have that information, we will share it and maybe at our next CBOC meeting we have a deeper discussion.

Question: Since there is a back order issue, is E.F. Green Junior School complete?

Clem Medina responded: We are still working on the furniture. We have our Certificate of Substantial Completion along with our Certificate of Occupancy from the City of Baytown.

Dr. O'Brien commented: There are only punch list items left.

Quarterly Material Report - Speaker Dr. McCall

Hard copies were given out for the Quarterly Material Report for the Period Ending Q2/2021 Dated July 1, 2021

Construction material prices continue to rise and deliveries fall further behind on increasing demand, a covid broken global supply chain, and shrinking factory inventories. Suppliers will not hold prices for some materials beyond 15 days. Deliveries in some cases are running months behind. Institute for Supply Management report biggest price jump in 42 years in June 2021 and 13th straight month of price increases.

Implications for Owners and Projects: Allow more time in schedules, or openings may get trapped by missing materials. Utilities having issues; secure utilities early. Permits running far behind. Budget higher cost.

This handout was to share this information with you, not only for the projects that we are looking to complete in the near future but also for the projects that we are gearing up to start. We are talking about the Fine Arts Buildings, Gentry and Lee High School. So we have to take this into consideration along with the delays and the cost of construction. We are staying on top of this and making the best decisions so we can stay within budget. To be honest, there may come a time were we come to you for endorsements in order to get these project done. At this moment in history, it may require more time and additional money than what was budgeted for.

We normally receive this report, quarterly. We will be entering our 3rd quarter, so our next quarterly report should be at the end of October or early November.

Clem Medina commented: On the Fine Arts Project at Gentry and Lee we go to bid in a month and should receive this in early November. We anticipate at our next CBOC meeting that there will be an endorsement request because of the inflations that we are starting to see. We are currently 10 to 15% over what we had budgeted for.
