Question/Answer:

Question: Will there be separate female and male official bathroom spaces in the field house?

Answer: Yes.

Question: Is there a sign that says female only?

Answer: No, restrooms are unisex.

Question: What is the square feet for this building?

Answer: We are at about 16,000 sq. ft. and can hold comfortably 65 players per locker room.

Question: What kind of wall is it that will separate the rooms? Answer: It is a roll down door that will separate the rooms. Question: What is the square footage for the training rooms?

Answer: It is about 200 sq. ft.

Question: What accommodations have we made for female sports like track and soccer?

Answer: We did discuss this situation. There will have to be extra monitoring during games but the guys will use one side of the

building while the girls will use the other side. Question: Will we keep the old scoreboard?

Answer: No.

Question: With the new scoreboard will there be something to protect it when kicking field goals?

Answer: Yes, this is something we have been discussing and we are thinking of using a net. Question: The current scoreboard was issued by a sponsor. Is it still under a sponsor contract?

Answer: I believe it has run out. The old scoreboard had permanent signs, where as the new scoreboard will allow sponsors to purchase per game or for the season and can be changed out with the images on the actual screen. That was a great question and I will follow up with the marketing team as well.

Question: With the filed house going in, do we have to do an additional detention pond?

Answer: No, we are good on that. They are planning on the Transportation Center detention pond having adequate capacity for the entire site, which includes the stadium. We are exempt because the county considered it already impervious surface.

Question: What is the square footage for the Technology Center?

Answer: It is 7,500 sq. ft.

Question: Is there an awning that goes from the main building to this center?

Answer: No, this building is completely separate because it has a different function.

Question: Matt currently has more workshop space in his current building will he retain that space?

Answer: Yes, he will still retain the workshop space and that is supplemental to that location.

Question: As far as conferences and public events/banquets for Education Service Center Phase 2, will there be enough room for that?

Answer: Yes, absolutely. This is where our schools can have their banquets instead of renting out hotel space or other centers.

Question: Will this still accommodate 500 people including the tables?

Answer: Yes.

Question: What is the square footage for this building?

Answer: 19,000 sq. ft.

Question: Can the community rent this out?

Answer: Yes, this is our goal.
