- 2. Mr. Clem Medina provided an overview of the completed projects:
  - The District Wide Carpet Project was completed the weekend of 01/20/2018.
  - Sterling HS cafeteria was completed over the Christmas break.

- 4. Emergency Lighting and lighting controls is at 99 % complete.
  - Emergency lighting, and lighting controls are in a holding pattern to replace faulty ballast. Sylvania is responsible for replacing the new ballast.

- 5. Sterling HS Culinary Arts Lab is at 35 % complete:
  - MEP system is being installed.
  - Vent hoods have been installed.
  - Paint of classroom is ongoing.
  - Project is on schedule to be complete over Spring Break.
- 6. MEP 4 is at 95 % complete:
  - 2 light poles need to be installed in the FMC parking lot.
  - New generators at Lee and FMC awaiting commissioning.
- 7. Ag Building is at 50 % complete:
  - Structural Steel is complete
  - Sheet metal installation is complete
  - Exterior brick façade installation is ongoing
  - Drive way and parking lot is complete
  - The contractor is aiming to move the animals to the new barns at the end of Feb.
  - Project is on track to be completed in April
- 8. FCA Renovations is at 98 % complete. Remaining items are:
  - Working the punch list at Sterling, Crockett, Hopper.
  - Project has over \$3 million in savings.
  - Roofing at Ashbel Smith, the gym roof at Austin and the roof at San Jacinto will be replaced.
  - Crockett needs tile replacement in the restrooms and the doors at FMC building replaced.
- 9. Technology Center is at 38 % complete:
  - Structural Steel is complete
  - Metal decking in nearly complete
  - CMU blocking is complete and Brick veneer is underway
  - MEP top-out is ongoing
  - Boring of Main street for sewer and water is complete
  - Still on track to make our summer August 17<sup>th</sup> completion date.

## <u>Design</u>

10. Green Center has been moved into the design portion of the bond and looking to build back the interior space, pre Hurricane Harvey Flood. Slight modifications need to be done to the conference room.

#### **Planning**

- 11. Lee drive transportation is still in a holding pattern. The district is still evaluating the project to see how that project fits the district's needs.
  - Lee College is not in a position to pursue.
  - Possibly lease the property out.

### **Project Groupings**

- 2. Mr. Medina provided an overview of the projects groupings:
  - 95% complete with the current 2013 Bond with a \$3.9 million savings.
  - LAN and the District are identifying construction projects to submit to the CBAC for their approved completed via the savings from the 2013 Bond
