

Projects Under Construction

- MEP 3 100% The District is processing final pay application.
- REL Windows 100% The District is reviewing final pay application.
- 2016 Life Safety/Sound Pkg work is complete at Austin ES, Stallworth Stadium, Bowie ES, Carver ES, Crockett ES, the Administration building, and is wrapping up at Highlands ES, and Hopper Primary. Work continues at Cedar Bayou JS, Baytown JS, and Gentry JS. A walk-through with the Harris County Fire Marshal scheduling for Hopper and Highlands Elementary this week.
- Emergency Lighting Punch list working at P. Hyland, Highlands ES, Hopper Primary, San Jacinto as well as the Administration building. The contractor's replacement crew continues to review and correct deficiencies of work previously installed.
- Carpet Replacement (district-wide) Work continues at Baytown JS, Cedar Bayou JS, Carver ES, Travis ES, and REL HS. Work on hold until contractor provides revised scheduling.

Projects In Design/Bidding

- Ag Facility Bids were received and have been reviewed. A contractor recommendation went to the Board on the April 10th Board meeting. Contract negotiations working to be followed by notice to proceed letter to contractor.
- FCA Renovations, Repairs, and Upgrades Review meetings are ongoing with all team members. A/E revising contract documents to address City of Baytown review comments. The contractor to receive bids April 20 on Phase 2 work.
