

**GOOSE CREEK CONSOLIDATED INDEPENDENT SCHOOL DISTRICT  
2014-2015 PUBLIC NOTICE OF TEACHER QUALITY  
(HIGHLY QUALIFIED TEACHER REPORT)**

The No Child Left Behind (NCLB) Act of 2001 requires each local education agency (LEA) to publicly report progress of the LEA and its campuses toward meeting the “highly qualified” teacher requirements.

The following standards are required to be considered a “highly qualified” teacher:

- Has obtained full Texas teacher certification
- Holds a minimum of a bachelor’s degree
- Demonstrates subject matter competency in each of the academic subjects taught

Note: Competency is obtained by passing the TExES content certification exam and/or completing 24 college hours in the subject area taught.

The District has made significant annual gains and has met the United States Department of Education and Texas Education Agency annual target of 100% “highly qualified” teachers in all core academic subject areas as defined by the No Child Left Behind Act.

The chart below contains the Goose Creek Consolidated Independent School District percentages of “highly qualified” teachers by campus, classes taught, teachers in high-poverty schools, and teachers participating in high quality staff development. These data elements are the state-wide targets as required by the United States Department of Education. The data is based on the November 17, 2014 reporting date. This report may be amended in June 2015, if deemed necessary.
